PREFACE

The Pacific Islands Development Program at the East-West Center frequently receives inquiries from individuals and companies wanting to purchase marine products from countries in the Pacific islands region. For example, inquiries have been recently received from U.S. companies that want to purchase prawns and shark fins from the region. Often it is difficult to know where and to whom to direct these persons. Thus this Directory was compiled to increase the awareness of the range of marine products available in the Pacific islands region and to possibly facilitate trade in these products. No such Directory currently exists.

An effort has been made to make the Directory as comprehensive as possible. Appropriate agencies in all countries and territories in the Pacific islands region were contacted and invited to participate in the Directory's compilation. A total of twenty-four countries and territories were contacted and seventeen replied. Of the replies received five countries and territories indicated that they had no marine products for export at this time, and so they have been excluded from the Directory.

Listings for the Directory are based solely on information supplied by appropriate agencies in countries and territories in the Pacific islands region. Listings are by (1) country/territory and (2) products exported.

It is hoped that the Directory will be of benefit to those countries and territories in the Pacific that want to further promote trade in marine products. Officials in the region are at liberty to use the Directory for their own purposes.

Compilation of this Directory would not have been possible without the assistance of many people in the Pacific islands region. THE EAST-WEST CENTER is a public, nonprofit educational institution with an international board of governors. Some 2,000 research fellows, graduate students, and professionals in business and government each year work with the Center's international staff in cooperative study, training, and research. They examine major issues related to population, resources and development, the environment, culture, and communication in Asia, the Pacific, and the United States. The Center was established in 1960 by the United States Congress, which provides principal funding. Support also comes from more than 20 Asian and Pacific governments, as well as private agencies and corporations.

Situated on 21 acres adjacent to the University of Hawaii's Manoa Campus, the Center's facilities include a 300-room office building housing research and administrative offices for an international staff of 250, three residence halls for participants, and a conference center with meeting rooms equipped to provide simultaneous translation and a complete range of audiovisual services.

PACIFIC ISLANDS DEVELOPMENT PROGRAM

The purpose of the Pacific Islands Development Program (PIDP) is to help meet the special development needs of the Pacific Islands region through cooperative research, education, and training. PIDP also serves as the Secretariat for the 1980 Pacific Islands Conference, a heads of government meeting involving leaders from throughout the Pacific region, and for the Pacific Islands Conference Standing Committee, which was established to ensure follow-up on development problems discussed at the Conference.

PIDP's research, education, and training activities are developed as a direct response to requests from the Standing Committee. PIDP's projects are planned in close cooperation with the Committee to ensure that the focus and the organization of each project address the needs identified by the heads of government on the Committee, a process which is unique within the East-West Center and in other research and educational organizations serving the Pacific.

A major objective of the program has been to provide quality in-depth analytical studies on specific priority issues as identified by the Pacific Island leaders and people. The aim is to provide leaders with detailed information and alternative strategies on policy issues. Each Island country will make its own decision based on national goals and objectives. Since 1980, PIDP has been given the task of research in six project areas: energy, disaster preparedness, aquaculture, government and administrative systems, roles of multinational corporations, and business ventures development and management.
